### Speak Up About Your Needs

Five year old Danielle was ill for several days. Finally her mom took her to the doctor. After a thorough exam, the doctor declared that she had strep and that he would have to give her some shots. Danielle let the doctor and everyone else in the office know that she didn't like that idea one bit and screamed during the shot process. Before they left the office, mom stepped to the counter and took out her checkbook. Danielle was appalled. With tears still running down her red face she shouted, "Are you really going to PAY for THIS?"

Yes, sometimes the very thing we need the most is not only painful, but we have to PAY for it. That makes me chuckle.

It costs something to deal with our hearing loss. It costs time, lots of money, becoming assertive, educating ourselves, seeking out ways to cope (such as SHHH meetings), and perhaps even swallowing some pride. We don't want to appear old, or disabled,

or incapable, but wearing a hearing aid can make us feel as if that is exactly how others view us. That is where the pain comes in. And we add to the cost when we don't explain.

Actually that is not how others view us. People are often confused as to what to do to help us. They are grateful to have us explain to them what a hearing loss is like. They DO want to helpthey just don't know how. Here's some ways you can help them help you:

Explain that you have a hearing loss and that it would be helpful to you if they would speak slowly and clearly - but not to shout.

Try to move to a quiet place so it's easier to hear.

Ask for a clue as to what they are going to talk about.

Use assistive listening devices to help, and explain what they do and how they can use the microphone or other items to help you.

Let them know when you do understand so that they aren't frustrated that you're not responding. Hearing people don't really know if we "get" it or not, if we don't tell them.

Don't bluff.

Remember that you are responsible to make it easier for yourself as well as others.

### Trouble Finding a Cordless or Cell Phone You Can Use?

Have you shopped for a cordless or cell phone and had trouble finding one that will work with your hearing aid or cochlear implant? You can do something about it!

When you shop for a phone and cannot find a phone that you can use without interference, please file an informal complaint with the Federal Communication Commission (FCC). There just have not been enough complaints filed and the law is enforced via a complaint process. We need 25 complaints to go into the FCC.

To complain you need to do the following. It is very easy to use email. *fccinfo.@fcc.gov* 

Provide the following information:

- your name, address, email, phone
- name of manufacturer of phone
- name of carrier of the system you were trying to use
- type of phone and model number
- location where you purchased or tried to purchase phone
- specific problem you encountered e.g. does not work with telecoil; causes interference when held up to ear with hearing aid
- how do you want the problem resolved

There are also problems with cordless phones causing interference. These are wireline phones and are fully covered



by the Hearing Aid Compatibility Law. If you find you cannot use a cordless phone because of interference – many people are finding the digital spread spectrum cordless phones cause interference with their hearing aids, the same applies - email the FCC and file an informal complaint. Use the same information as above. Speak up! Together we can make a difference in the world.

## NCRAR Conference Big Success

On October 8-10, 2003, NCRAR hosted 168 attendees from 28 states plus Denmark, Switzerland, and British Columbia at its inaugural conference, "Auditory Rehabilitation: A Multidimensional Approach". The conference opened with a reception which was attended by conference participants and special guests including representatives from the offices of Senator Ron Wyden, Congressman Earl Blumenauer, Congresswoman Darlene Hooley, and Congressman David Wu, officers of Veteran Service Organizations, and members of the NCRAR National Advisory Board. The reception opened with an official proclamation from Portland Mayor Vera Katz proclaiming October 8th to 10th Auditory Rehabilitation Days in Portland.

There followed two days of sessions in which eight internationally respected clinical researchers presented and discussed the latest advances in the field of auditory rehabilitation. #### Drug May Protect Ears From Chemotherapy

Ongoing human clinical trials with sodium thiosulfate are showing great promise in protecting the ears of brain tumor victims from chemotherapy damage to the inner ear.

Up until the trials began, 50% of brain tumor victims who received chemotherapy had severe enough hearing loss to require aids. Now it's 5%.

Trials in children are beginning, and the manufacturer hopes to receive approval by the Food and Drug Administration in two to three years.

## **Community Access Hearing Assistive Technology Program**

In April of 2000, the Oregon Hard of Hearing and Deaf Alliance (OHHDA), an advocacy coalition of over 25 public, non-profit and for-profit organizations representing Oregonians with hearing loss, applied for a two year grant with the Meyer Memorial Trust to fund a Hearing Assistance Technology project. The goals of the Community Access Hearing Assistive Technology Program, CAHAT for short, are to enable people with hearing loss to function at parity with hearing people and to improve communication among those with hearing loss through the availability of hearing assistance technology. In October of the same year, the Meyer Memorial Trust approved the grant of \$48,000 "to purchase hearing assistance technology and equipment for statewide distribution." (The Meyer Memorial Trust was created by the personal philanthropy of Fred G. Meyer and is in no way connected with Fred Meyer, Inc.)

CAHAT equipment has now been distributed to 7 sites throughout the State of Oregon. The intent of the program is not to replace the requirements of entities mandated by the Americans with Disabilities Act of 1990 to provide accessibility for hard of hearing and deaf individuals participating in their programs. Rather, the purpose is to make assistive equipment readily available to the general hearing impaired community. There are times, however, when some organizations will be called upon to provide access for events that will have many more hearing impaired participants than they are equipped for. Loan of equipment by the CAHAT program may be approved if it will be available at the time of the event.

#### When the Hearing Aid Whistles

A whistling hearing aid can be very annoying and disturbing. The high-pitched sound is feedback from a hearing aid and you can do something about it.


Wax in the ear canal may prevent sound from traveling into the ear. The sound being forced back out of the ear results in the high-pitched whistle. The wax needs to be removed by a physician.

Wearing hearing aids on full volume often creates feedback. Turn down the volume or have the hearing aids checked if you always need high volume to hear properly.

And incorrectly fitted ear mold can cause the hearing aid to make the whistling sound and you need to be se your hearing health care professional to get anew or modified ear mold.

The plastic tubing that joins some hearing s to the ear mold can become hardened and shrink puling on the ear mold so it no longer sits correctly in the ear. This can cause the whistling sound and a new tubing is needed. Tubing should be changed about every six months or when it loses its flexibility.
